CONTINUING CONTRACT BETWEEN Shipper and Motor Carrier through Broker MC#

Between All About Freight Rates hereinafter **Broker** and Motor Carrier "MC" AGREE that MC is an "Independent Contractor" WHO IS RESPONSIBLE FOR ALL TAXES AND LICENCES TO OPERATE as An **AUTHORIZED MOTOR CARRIER** and in the possession of, and responsible for, cargo tendered by shipper/Consignor (hereinafter "shipper") for transport. **MC** and/or **Shipper** engage in United States: Standard Short Form-**Bill Of Lading**, as proof of their exclusive liability for Public and Cargo Safety without reference to **Broker**. Subsequent to this **CONTINUING CONTRACT, Broker** will provide, **Contract** and "**RATE CONFIRMATION**" as part of a series of shipments under the **Continuing Contract I transportation** indicating terms and conditions for the individual transportation booking **MC** and the **Shipper** in the **Rate Confirmation** sent by Broker is proof of the MC primacy and control of the Transportation **Bill of Lading. Broker** declares no interest in the MC's Cargo, no responsibility for pick up/ delivery appointments, no control of MC driver personnel. In consideration of the **Continuing Contract** and each **Rate Confirmation. Broker** agrees to collect from **Shipper** and remit to **MC**, all the transportation funds, less an agreed reasonable commission within 30 days of submission of MC Freight Bill and clear Proof of Delivery. MC agrees to extend credit to the **Broker** in the amount listed, and for the Transportation service outlined in the **Rate Confirmation. MC** agrees that amount listed satisfies all MC transportation and accessorial charges, including but not limited to, Taxes and Fuel Surcharges. Charges after consignment re MC to immediately "**NOTIFY**" **Broker during the Claim**, in writing or e-mail, so Broker may properly represent MC additional charges to the **Shipper**. Failure to Notify, MC forfeits any accruing Freight Bill Rights. **MC** accepts the Credit Credentials and License as proof of ability to arrange freight movement. Either party may

terminate this contract within 24 hours written notice by either party. RATE CONFIRMATION as an **ADDENDUM** to the **Continuing Contract** and may not be terminated until safe delivery of all loads.
